

# Sonia decisive on Telangana this time



This time, the Congress high command seems to be very decisive on carving out a separate Telangana state out of the 56 year old Andhra Pradesh state comprising of Telangana and Andhra regions. Unlike in the past, the party leadership is appearing determined to resolve the long pending issue, especially party chief Sonia Gandhi seems like almost made up her mind to divide AP, in tune with the wishes of over four crore people of Telangana, a promise she made to them three and a half years ago that too sentimentally linked to her birthday on 9th December, 2009. Indications available till now suggest that the upcoming meeting of Congress Working Committee (CWC) which may meet in the next 10 days, is expected to finalize the roadmap for formation of a new state out of Andhra Pradesh.

Two scenarios are appearing loud and clear - first one being, the new state with 10 Telangana districts with Hyderabad as its capital. The next scenario is adding of two Rayalaseema districts – Kurnool and Anantapur - to the 10 Telangana districts and Hyderabad as its capital. In either case, Andhra Pradesh is bound to be divided into two and Seemandhra region will have a separate entity. A majority of Congress leaders from Kurnool and Anantapur are known to be secretly wishing that Rayala-Telangana becomes a reality.

According to sources, Union Minister of state for Railways - Kotla Surya Prakash Reddy, and state ministers TG Venkatesh, Erasu Pratap Reddy belonging to Kurnool and N Raghuveera Reddy belonging to Anantapur districts have already conveyed their willingness for Rayala Telangana, by merging Kurnool and Anantapur districts with Telangana. Only hardcore elements like minister S

Shailajanath and MP Ananta Venkata Reddy said to be close to Late YSR are opposing this move. But, they are in minority.

The Congress high command has decided to go ahead with the process of formation of separate state as it would best serve its political interests in the run up to the next general elections in 2014. By setting in motion the process, the party feels that it can neutralize three significant political rivals – YS Jaganmohan Reddy's YSRCP in coastal Andhra and Rayalaseema, K Chandrasekhar Rao's TRS in Telangana and N Chandrababu Naidu's TDP in both the regions.

A strong indication to this effect was available when Andhra Pradesh Assembly speaker Nadendla Manohar who was ostensibly summoned by the union government called on Congress president Sonia Gandhi in Delhi on Thursday. Even after Manohar, who represents Tenali constituency from

Guntur, in coastal Andhra, tried to explain opposition to any moves to divide the State; Sonia Gandhi is learnt to have told him to get ready for a special session on Telangana.

When enquired, Manohar declined to reveal to media the details of his meeting with Sonia, but sources close to him confirmed that the Congress president had probed about the possibility of AP Assembly passing a resolution on bifurcation of the State. It appears that high command has almost decided to push Telangana issue in the house for a possible debate, though not sure of the outcome. This Assembly resolution part is one of the 12 steps in 215 days roadmap that was circulated by AICC general secretary Digvijay Singh to the three state leaders at the Congress core committee meeting in Delhi on July 12th. Though, no source is attributed to the roadmap, Singh told the state leaders that it was prepared by legal experts in the Union Home Ministry.

According to the roadmap, that currently became a major debating issue in Hyderabad, at least 7 months and 5 days are needed to complete the process for formation of Telangana state. The process will begin only after the Congress Working Committee (CWC) which is expected to meet by July 28th, resolves in favour of Telangana state creation. As per the party roadmap, Step 1 (10 days) for AP assembly passing a resolution for Telangana state, Step 2 (30 days) for the union cabinet preparing a note, Step 3 (90 days) for the home ministry setting up a Group of Ministers (GoM), Step 4 (15 days) for GoM's recommendation, Step 5 (7 days), for the cabinet nod, Step 6 (2 days) to refer the matter to AP Assembly for 2nd time. Step 7 (30 days) for AP Assembly passing a resolution after discussing the arrangements finalized by the union cabinet, Step 8 (7 days) on the union law ministry preparing a draft Bill, Step 9 (5 days) for the union cabinet okaying the draft Bill,

Step 10 (2 days) for Lok Sabha passing the Bill, Step 11 (15 days) Assembly passing the Bill and Step 12 (2 days) for the presidential assent to the Bill.

Now, the leaders of both the sides (for and against the division of AP) are intensely studying and discussing the ways and means to overcome hurdles in the roadmap to their advantage. "This clearly shows that Telangana is going to be a reality soon. Once the CWC passes a resolution on Telangana, the roadmap comes into effect," Deputy CM Damodar Rajanarsimha said. But, Damodar or many of Telangana Congress leaders have no objection, if the Centre prefers Rayala Telangana, which includes Kurnool and Anantapur districts. This new proposed state will have larger number of MPs (21) and MLAs (147). "We need not bother that our new state would be a smaller one," a senior Congress leader who wished not to be quoted said.

The response of Congress is almost positive to Rayala Telangana. But, that

of Jagan's YSR Congress, TDP and TRS are obviously negative to this new idea. Jagan's YSRC party will almost become irrelevant in Rayala Telangana, also will be weaker in Seemandhra since coastal Andhra plus two Rayalaseema districts of Kadapa and Chittoor will have changed equations. It is expected that except in Kadapa, Jagan may not be able to have any influence in Seemandhra post state division. That would be a disadvantage to him as he is keen on becoming the CM of atleast the new Andhra state that will have 11 districts. The people of Coastal Andhra with 9 districts may not allow someone from Kadapa to dominate them. The current leadership of TDP led by Chandrababu Naidu is likely to face grave challenges in both the regions, because of its ambivalence stand to the separate statehood demand.

The TRS chief K Chandrasekhar Rao is naturally a worried man as his clout will drastically go down in the new state of Rayala Telangana. Already, TRS is limited to a few areas in

Telangana region and not a major force in parts of the region like Khammam, Nalgonda (except for Aler and Bhongir belt) and Hyderabad, Ranga Reddy districts. Sulking over the attitude of Congress high command which had ignored him completely in the present process of taking a decision on Telangana, KCR has decided not to merge his party with Congress for the time being. At the same time, he wants to emerge as a major force in the Telangana of 10 districts. But, Rayala Telangana will play spoilsports to his dreams as TRS has a zero presence in Kurnool and Anantapur which have 4 MP seats and 28 MLAs seats.

This discomfort and unease of these three parties – TDP, TRS and YSR Congress – perfectly fits the bill of Congress and Sonia Gandhi for deciding in favour of Rayala Telangana. Moreover, the MIM is now strongly favouring Rayala Telangana as it would protect the interests of Muslims, who are concentrated in this region. Actually, the MIM has been facing a lot of

problems on account of its proximity with Jagan's YSRCP but now is ready to dump Jagan in favour of Congress as it suits its purpose. To justify supporting congress, the MIM will claim to ally with Congress on the pretext of preventing BJP's Narendra Modi from emerging stronger. Besides when the state is being divided, there is no benefit in rallying with Jagan's YSRCP which is a non entity in T-region. Not to forget the bitterness MIM has for Chief Minister Kiran Kumar Reddy, for his actions that caused both top leaders to spend time in jail. Now, the Owaisi Brothers are keen to have Telangana state to see the end of arrogant Rayalaseema leaders.

By opting for Rayala Telangana, Sonia can also please her Muslim vote bank and get back an ally, MIM too. That way, UPA will get one more ally to support the PM candidacy of Rahul Gandhi. This is a win-win situation to Sonia Gandhi.

### NEET Verdict is not so NEAT

he Supreme Court verdict delivered on 18th July, quashing the National Eligibility and Entrance (NEET) is a cause for cheer to the managements of private unaided medical colleges. It is also a boon to the owners of coaching centers which thrive on the loopholes of the separate entrance tests held by different states. But, not definitely a good news to lakhs of students who burn their midnight oil to make to the tough medical entrance tests to become doctors in their lives. In the name of allowing private medical colleges, an unbridled freedom and liberty to conduct their own tests and make admissions in their choice, the SC has scuttled the prospects of a uniform test for medical seats.

The judgment delivered by a 2-1 majority bench headed by Chief Justice of India Altamas Kabir and Vikramjit Sen (who endorsed it) and AR Dave (dissenting) brought curtains on the long drawn battle between the private college managements and the Medical Council of India (MCI) which made frantic attempts to streamline the MBBS admissions for over two years.

The MCI has been in the dock since its disgraced chairman Ketan Desai was arrested in a bribery scam two years ago. The MCI has also noticed many anomalies in the common entrance tests held by the different state governments



and found that the students who followed the CBSE syllabus had not many seats to compete with at the national level.

Hence, the MCI in association with the Union HRD Ministry has brought up a proposal to conduct a Nation-wide common entrance test, named as NEET, two years ago. But, many state governments including Andhra Pradesh have opposed it on the ground that the test would infringe on their rights and that their own tests would become redundant.

Government of Andhra Pradesh has sought and obtained special permission from the apex court to be exempted from

NEET last year and also this year. Though, the courts allowed exemption last year, they have given no such relief this year. As a result, around 1.5 lakh students from AP have appeared for both EAMCET and NEET this year, facing many difficulties. This judgment has made NEET irrelevant, if a student wanted to seek an admission based on his or her EAMCET rank. At the same time, this verdict also has affected another eight lakh students who had appeared for NEET this summer. Now, the 31,000 MBBS and another 5,000 PG medical seats will be filled up based on local entrance tests and procedures.

However, the judgment is not clear on many aspects like the need to have an

All-India level common entrance test for medical admissions, a proposal pending for long. The SC ruling that private medical colleges can have their own tests, whether individually or in groups of 10 or 20 colleges may go against the interests of majority of the students.

Already, there are doubts over the verdict, delivered on the last day of the office of outgoing Chief Justice of India - Altamas Kabir and the Government of India is planning to seek a revision. It is advisable to have a comprehensive strategy to deal with medical admissions, a sensitive issue, instead of coming up with quick-fix solutions. •

# Kotagiri Vidyadhara Rao passes away

Inspired by the entry of Telugu film actor K Chiranjeevi into politics from the film industry, Vidyadhara Rao snapped his two-and-a-half decade long association with the Telugu Desam Party (TDP) and joined hands with him in launching the Praja Rajyam Party (PRP). Later, Vidyadhara Rao switched to the ruling Congress along with Chiranjeevi when the PRP was merged into the congress party.

The sudden demise of Kotagiri has shocked many leaders who condoled his sudden demise. Several political leaders paid rich tributes to the departed soul. Union Tourism Minister K Chiranjeevi has rushed to Eluru from Delhi immediately upon learning the news of Kotagiri's death. Union Minister Kavuri Sambasiva Rao, State Bosta Satyanarayana, Ministers Ramchandraiah, Kanna Laxminaryana, Ganta Srinivas, Vatti Vasanth Kumar and senior congress leader Dr KVP Ramchander Rao visited the residence of late Kotagiri Vidyadher Rao to condole his death. Chief Minister Kiran Kumar Reddy paid rich tributes and ordered the district administration to accord a state funeral to the departed leader. Speaker Nadendla Manohar and former Chief Minister Chandrababu Naidu paid rich tributes recalling the services of the departed leader.

Many leaders cutting across the party lines have been paying tributes to late Kotagiri Vidyadhara Rao whose funeral is expected to take place in his native village on Sunday morning. Thousands of well wishers have arrived in his native East Yadavalli village under Kamavarapukota Mandal, West Godavari District to have a glimpse of the departed soul. •

lamboyant senior congress leader and former minister Kotagiri Vidyadhara Rao died of cardiac arrest at his residence in Eluru on Saturday morning. He was 67 and is survived by his wife and two children. His son Sridhar and daughter Anita were with him when the end came around 7-30 AM. He was staying in Eluru for quite some time to work for the victory of his daughter, a Sarpanch candidate in the fray at his native East Yadavalli village under Kamavarapukota Mandal, West Godavari District.

Kotagiri Vidyadhara Rao began his career as a village sarpanch and rose to become a Minister, handling a range of portfolios in the Cabinets of Telugu Desam Party (TDP) Founder NT Rama Rao and N Chandrababu Naidu. He was Agriculture Minister in NTR cabinet. Later Chandrababu Naidu took over; Vidyadhara Rao was made Panchayat Raj Minister for

about two years. Again he was moved to Agriculture portfolio till 1999 general elections. After the TDP retained its power, Vidyadhara Rao became Major Industries Minister. He served the Chintalapudi Assembly segment as a Legislator and Minister from the Telugu Desam Party for more than two decades i.e. from 1983 to 2004. He was Chairman of the Public Accounts Committee during 1987-89.

Vidyadhara Rao, after graduating as a Mechanical Engineer, from Bangalore University joined public life early in life. He served as the Sarpanch of his village and quickly acquainted himself with the problems of the rural people. His ascendency as Minister for Agriculture and Panchayat Raj was largely because of his expert knowledge in the related fields. In fact, Kotagiri's penchant for taking up challenges in the policy making has compelled the then

# ARE WE CAPABLE OF DISASTER MANAGEMENT?

isaster Management comprises of Prevention, Mitigation and Preparedness in pre-disaster phase, and Response, Rehabilitation and Reconstruction in post-disaster phase. Natural calamities, of one description or the other, affect nations all over the world. Because of the large geographical size of the country, India often faces natural calamities like Floods, Cyclones and Drought occurring fairly frequently in different parts of the country. At times, the same area is subjected to floods and drought situation in successive seasons or years. While not all natural calamities can be predicted and prevented, a state of preparedness and ability to respond quickly to a natural calamity can considerably mitigate loss of life and property and the human suffering and restore normalcy at the earliest. It is, therefore, of paramount importance that a plan of action for dealing with contingencies that arise in the wake of natural calamities is formulated and periodically updated.

Types of Natural Calamities: Different natural calamities can be distinguished from each other in terms of their nature and extent of their impact. Calamities like Earthquakes, Hailstorms, Avalanches, Landslides, etc occur quite suddenly but they are restricted in their impact in terms of time and space. Similarly, though Floods and Cyclones occur with some element of warning, yet their occurrence is confined in duration. Drought, on the other hand, spans over a much longer time-frame and its adverse impact on the economic activities and life of an area is of a more lasting nature. The measures required to meet the threats posed by different calamities, therefore, differ considerably in terms of disaster preparedness and amelioration of the economic and social life of the affected people.

Major and Minor calamities: Natural calamities may be broadly grouped into major and minor types depending upon their potential to cause damage to the human life and property. While natural calamities like earth-quakes, droughts, floods and cyclones could be regarded as major, hailstorms, avalanches, landslides, fire accidents, etc whose impact is localized and intensity of the damage is much less can be categorized as minor calamities. Minor calamities like hailstorms, avalanches, landslides and fires also occur without any appreciable degree of forewarning and cause damage to properties and lives. However, areas prone to such disasters also could be identified and certain precautionary measures taken in the context of potential threat requiring general awareness and an ability to relate to a predefined system of appropriate responses on the part of the local administration.

#### **National Disaster Management Authority:**

The Government of India (GoI), in recognition of the importance of Disaster Management as a national priority, had set up a High-Powered Committee (HPC) in August 1999 and also a national committee after the Gujarat earthquake, for making recommendations on the preparation of Disaster Management plans and suggestion of effective mitigation mechanisms. The Tenth Five-Year Plan Document had for the first time, a detailed chapter on Disaster Management. Similarly, the Twelfth Finance Commission was also mandated to review the financial arrangements for Disaster Management. On 23rd December 2005, the Government of India enacted the Disaster

Management Act, which envisaged the creation of the National Disaster Management Authority (NDMA), headed by the Prime Minister, and State Disaster Management Authorities (SDMAs) headed by respective Chief Ministers, to spearhead and implement a holistic and integrated approach to Disaster Management in India. NDMA as the apex body is mandated to lay down the policies, plans and guidelines for Disaster Management to ensure timely and effective response to disasters. Towards this, it has the following responsibilities:

Lay down policies on disaster management; Approve the National Plan; Approve plans prepared by the Ministries or Departments of the Government of India in accordance with the National Plan; Lay down guidelines to be followed by the State Authorities in drawing up the State Plan; Lay down guidelines to be followed by the different Ministries or Departments of the Government of India for the purpose of integrating the measures for prevention of disaster or the mitigation of its effects in their development plans and projects; Coordinate the enforcement and implementation of the policy and plan for disaster management; Recommend provision of funds for the purpose of mitigation; Provide such support to other countries affected by major disasters as may be determined by the Central Government; Take such other measures for the prevention of disasters, or the mitigation, or preparedness and capacity building for dealing with the threatening disaster situation or disaster as it may consider necessary; Lay down broad policies and guidelines for the functioning of the National Institute of Disaster Management.

The Disaster Management Act, 2005 has made the statutory provisions for the constitution of the National Disaster Response Force (NDRF) for the purpose of specialized response to natural and man-made disasters. According to Section 45 of the Act, the Force has to function under the general superintendence, direction and control of the National Disaster Management Authority (NDMA) and under command and supervision of Director General, NDRF.

#### All the states try to prepare themselves in gearing up for the following roles:

- 1. Set up of Community tents to Affected Area
- 2. Create temporary shelters, health camps, nutritional feeding for pregnant women and infants up to 6 years, temporary roofing for families & equipments support for strengthening the state control room & district control room.
- 3. Arrange Tarpaulin Sheets, Halogen tablets, Bleaching Powder & Equipments among people of the affected area
- 4. Prepare and distribute family food packets
- 5. Procure motor boats in the flood prone districts.
- 6. Construction of Ware Houses.
- 7. Establishment of Emergency Operation Centers.
- 8. Procurement of Life Jacket, Tents etc for flood prone districts.
- 9. Procurement and Maintenance of Communication Equipments.
- 10. Establishing Early Disaster Warning System.
- 11. Capacity Building of Stake holders for Disaster Reduction.

12. Awareness Generation through posters, pamphlets, seminars/ workshops / symposia, celebration of international day for disaster reduction.

#### **National Institute of Disaster Management:**

The National Institute of Disaster Management constituted under the Disaster Management Act 2005 has been entrusted with the nodal national responsibility for human resource development, capacity building, training, research, documentation and policy advocacy in the field of disaster management. Section 42 (8) of the Act has made the Institute responsible for 'planning and promoting training and research in the area of disaster management, documentation and development of national level information base relating to disaster management policies, prevention mechanisms and mitigation measures'.

#### Section 42 (9) of the Act has assigned the following specific functions to the Institute:

- a. Develop training modules, undertake research and documentation in disaster management and organize training programmes.
- b. Formulate and implement a comprehensive human resource development plan covering all aspects of disaster management.
- c. Provide assistance in national level policy formulation.
- d. Provide required assistance to the training and research institutes for development of training and research programmes for stakeholders including Government functionaries and undertake training of faculty members of the State level training institutes.
- e. Provide assistance to the State Governments and State training institutes in the formulation of State level policies, strategies, disaster management framework and any other assistance as may be required by the State Governments or State training institutes for capacity-building of stakeholders, Government including its functionaries, civil society members, corporate sector and people's elected representatives.
- f. Develop educational materials for disaster management including academic and professional courses.
- g. Promote awareness among stakeholders including college or school teachers and students, technical personnel and others associated with multi-hazard mitigation, preparedness and response measures.
- h. Undertake, organize and facilitate study courses, conferences, lectures, seminars within and outside the country to promote the aforesaid objects;
- i. Undertake and provide for publication of journals, research papers and books and establish and maintain libraries in furtherance of the aforesaid objects.
- j. Do all such other lawful things as are conducive or incidental to the attainment of the above objects.
- k. Undertake any other function as may be assigned to it by the Central Government.

All said and done, the recent Uttarakhand disaster proved that we have still a long way to go to mitigate the Disasters. �

#### Can you tell us about your training days?

I started learning music on the Sitar under the tutelage of my mother Smt Pramila Dagar at the age of seven. After three years of initial training, I learnt the Surbahar and then the Rudra Veena from my father Ustad Zia Mohiuddin Dagar. After my father passed away in the year 1990, I continued my 'Talim' from my uncle Ustad Zia Fariduddin Dagar.


#### How was your Father as a Teacher?

My father had a lot of patience. He was very clear that I could take up music only if I had a good amount of interest in the same and would become a disciple. He would guide the important aspects of a Raga and leave us to work on them.

#### What's about the shift in the holding posture of the Rudra Veena?

My father shifted from the traditional posture of holding a Rudra Veena to the Carnatic style posture. It was possible to get good 'Meend' by doing so.

What is specific about your music?



I play the Dagar Vani style of Dhrupad on the Rudra Veena. I have incorporated the Dhrupad syllables (Te, Ta, Ra, Naa etc) in the playing of the Rudra Veena. This gives a unique and precise sense of timing in the cut-

ting of phrases while presenting the aalap, jor and the jhala.

#### Do you get time to teach music?

I teach vocal and instrumental music to

students from our country and also abroad.

#### How has this form of art been received in India?

My music has been recognized by the numerous awards given to me including the Sanskriti Award, instituted by the Sanskriti Foundation, New Delhi, 2006, The Yuvak Sadhak Award by the Sangeetendu Lal Mani Mishra Foundation, Bhopal, 2007 and the The Raza Award 2007 by the Raza Foundation; New Delhi.

#### How have your performances been received by the audience?



# Market scales 20,000 levels

tock market performance indicator Sensex has further continued the uptrend and has hit the major psychological level of 20,000. Market has gained nearly by 1,000 points in the last few days, and is now close to the two month high. Market has witnessed a surprise rally, even as there are reports of concerns about economic slowdown.

Market has witnessed a steady rally, even after few minor jerks, and managed to maintain a positive sentiment, on back of strong American Markets. But however, only select stocks and select sectors participated in the rally, while many sectors are still in a weakening trend. The first quarterly corporate results season have just started and the beginning has been good. Software segment stocks trend has turned positive trend, after the better than expected quarterly financial results from software giants Infosys and TCS. The strength of the American Dollar is expected to have a positive impact on the earnings of the software stocks and there is an increase of activity and interest in the mid-cap software

The quarterly results from the banking majors like HDFC Bank, and IndusInd Bank are also encouraging, but the overall sentiment in the banking stocks are still depressed. The Reserve Bank of India has increased the bank rates, as a monetary tightening measure to



control the depreciation of the Rupee. This is expected to have short-term pressure on the banking stocks, but however there are reports that the tightening policies could be reversed as soon as the pressure is over on the Rupee.

Major company Reliance Industries is expected to announce its quarterly results this month, which is expected to have an impact

on the market. Stock Market and especially banking stocks are keenly awaiting the next RBI meet on July 31st, and any major announcement on the banking lending interest rates would have an impact on the banking sector stocks.

Pharma and FMCG (Fast Moving Consumer Goods) stocks continued their

ascending trend, as there are expectations of strong performance. There are expectations that the GDP (Economic Growth), would revive in the next few quarters from current low levels.

Crude Oil is seen continuously on the ascending trend and is now at record highs of 6,400 levels in the commodity market. Crude Oil has been on the uptrend from 4,700 levels in the last few weeks, which is also a major concern now.

Precious commodities like Gold and silver are seen in a stabilizing trend in the last few weeks, in the MCX commodity markets. Gold is seen taking support at 25,000, while Silver is seen steady at 40,000, indicating signs of a possible recovery from current levels.

Technically, on the charts, Sensex is now placed just above the major psychological barrier of 20,000 where a consolidation is possible, in the short-term. It has to sustain above this key level to indicate a further uptrend. But in-case of any failure to sustain, and if declines below this key level, then it indicates a short-term weakness, for the short-term investors to be cautious. •
